



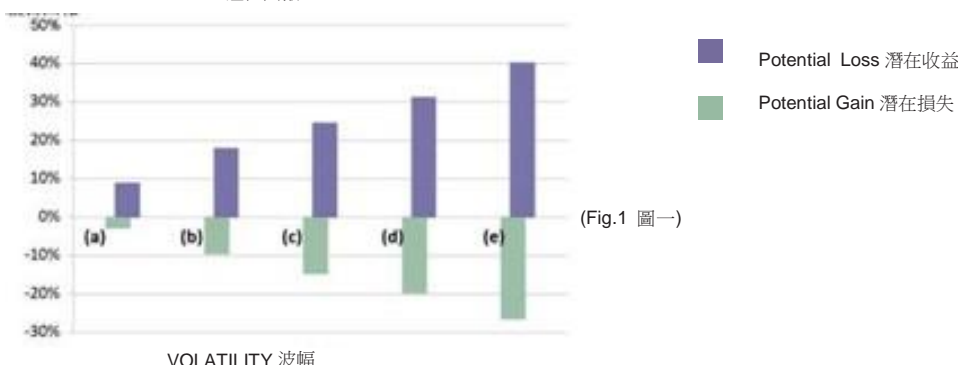

PORTFOLIO RETURN 組合回報



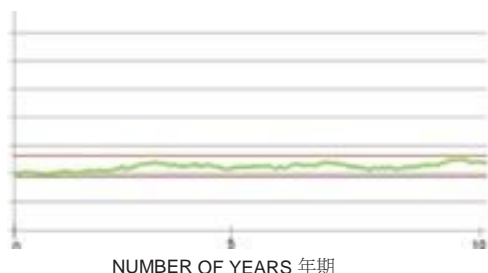

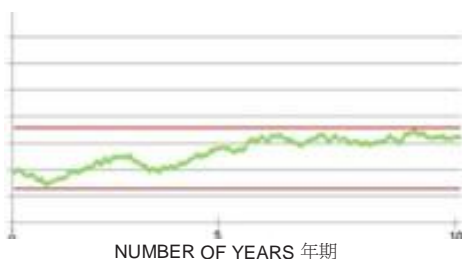

INDEX PRICE 指數價格



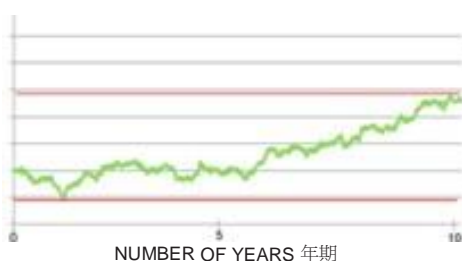

INDEX PRICE 指數價格



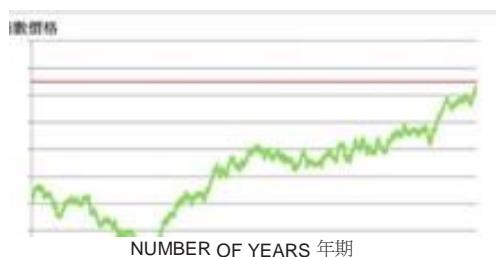

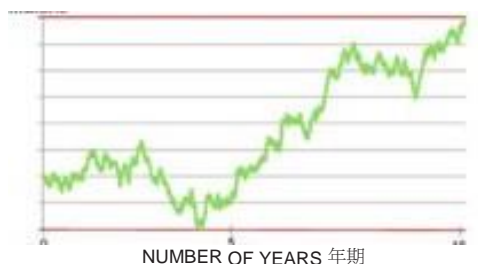
